NON-STERILE SOLUTION

Hazard Statements: Highly flammable liquid and vapor. Causes serious eye irritation. May cause drowsiness or dizziness.

SPECIFIC TREATMENT: (See First Aid section on the SDS.) Rinse mouth. Wash contaminated clothing before reuse.

IN CASE OF FIRE: Use dry san, dry chemical or alcohol-resistant foam to extinguish.

Store in a well-ventilated place. Keep container tightly closed. Store in well-ventilated place. Keep cool. Store locked up.
